Healthy, High Performance School Building Policies: *The State Role*

- State vs. Federal, local, and school district policies
- State policies can provide consistency and a common framework
 - 50 states vs. ~16,000 school districts
 - Exs. IL (nearly 1,000 school districts), NC (over 200)
- Many states already fund school construction and/or set minimum requirements

State HHPS Policies: What the Policies Do

- Emphasize the
 - integration of a
 - broad range of environmental and health goals into the
 - early planning, design and construction of school facilities

- Require school construction projects to use a
 - □ **HHPS** framework *e.g.*, LEED, CHPS
 - Allows discretion at project level to incorporate local needs

State Policies with HHPS Requirements: Key Implementation Issues

Oversight

 State role in school construction process varies widely



- Most HHPS policies don't address state oversight
 - What documentation must be submitted?
 - When and how will state review documentation?
- Some states are requiring formal LEED certification
 - □ OH, CO, IL, HI

Key Implementation Issues (cont.)

Costs

 State agencies need resources to do outreach, education, training and oversight




- Schools may face increased costs to meet HHPS standards
- Some state policies include financial support for compliance
 - MD, WA, OH
- Some state policies provide exemptions on a case-by-case basis
 - MD, CT, CO

Key Implementation Issues (cont.)

Evaluation

Critical to ensuring that HHPS policies achieve results



- Program evaluation, state implementation of policy
- Project evaluation, types of HHPS design features included in new school facilities and their impacts on health, environment and financial management of facilities
- A few states include evaluation in their HHPS policies
 - □ WA*, DC*, CO, OH

State Policies Providing Financial Incentives for High Performance School Construction

State	Date	Criteria	Funding Allocated
PA	July 2005	LEED (silver), GG	
CA	2006	CHPS-based checklist	\$100 million
NM	March 2007	LEED, Build Green NM, others	\$2 million
NH	July 2007	NE/CHPS	\$100,000 per fiscal year

 Policies authorize state to provide additional funding to school construction projects that meet HHPS criteria

State HHPS Building Policies: Future Opportunities

New HHPS policies should....

- Allow flexibility, but address priorities such as IAQ
 - Adapt, supplement third-party frameworks
 - Provide technical support to promote best practices
- Place greater emphasis on evaluation
- Make connection to best practices in operations and maintenance
